#### ROCK STAR BUYS THE MOST HAUNTED HOUSE IN CHICAGO

Residents of Evanston have long been aware of the creepy house at 2102 Brown Avenue. For decades it has been regarded as haunted by not only the local children but most of its neighbors, too. Now, Devon Razor the well-known shock rocker is moving in, adding further infamy to what some call the most haunted house in Chicago.

Built in 1928 by Remember Fletcher, a widow and former resident of Massachusetts, the house first attracted attention back in the 1930s. Neighbors recall the property gained an unsavory reputation, reporting strange sounds and colored lights emanating from the house in the late hours of the night. It is said that in the winter, snow would melt around Mrs. Fletcher's house long before the other homes on the street, while other accounts mention neighbors saying that the area around the house was always colder than elsewhere. In no time at all, the local children were spreading rumors that Remember Fletcher was a witch and that her house was haunted.

Following Mrs. Fletcher's death in 1958, the property has had a succession of owners, none of whom have stayed long. Missing persons, murder, and suicide have all been attached to the house on Brown Avenue, which one may speculate as key buying points for Devon Razor, whose performances and lifestyle are known to focus on the occult. We can only hope that suburban life is just what Mr. Razor needs to finally settle down and age gracefully, although this reporter, for one, doubts that will ever happen!

House of Horror Remembered

Long regarded as the most haunted house in Chicago, the two-story property standing at 2102 Brown Avenue in Evanston remains something of an enigma and a beacon for ghost hunters. With Halloween approaching, readers may recall the house's long and sad history.

The house, built in 1928, was said to have been designed by Remember Fletcher. Local folklore says Remember fled Massachusetts to escape accusations of witchcraft, but it seems she brought her spell books and cauldron with her to Illinois. Over the thirty years she lived on Brown Avenue, Fletcher's house was a source of spooky lights and weird noises, and a place locals stayed away from lest they be cursed by a spell. When Remember died in 1958, some said she has suffered a heart attack when summoning a devil in a midnight ceremony, although the coroner's records are a little more down to earth, giving old age as the cause.

With the passing of Remember Fletcher, the house continued to have a less than happy history. Purchased in 1959 by Ken and Sharon Lawson, calamity came to the new owners after only a few months, with Mrs. Lawson reported to the police as missing in April 1960. The loss of his wife is believed to have driven Mr. Lawson mad with grief, and he was committed to the Chicago State Hospital, better known these days as the Chicago-Read Mental Health Center. But even greater horror was to come. Just a few months later in 1960, the property was sold to a retired school principal and his wife, whose fates would seal the house's reputation as a place most folk would want to steer clear of. As, in early 1961, the school principal's wife viciously stabbed her husband to death and then slit her own throat.

The house remained empty for some ten years until purchased by the Bentley family, who again found no joy inside its walls. Allegedly, the Bentley's fled the house after just a month due to a rising tide of unexplained events caused by what they said were demonic spirits. Again, the property stood abandoned for a decade, till, in 1978, a Mrs. Alex Bellington moved in. After three weeks, she suffered a massive heart attack and died. She was just 55 years old.

### HANDOUT: DREAM 2 (CONTINUED)

Given the deaths and misery associated with the house, the firm in charge of selling it needed help, as no one wanted to buy it. People said it was haunted and that anyone who lived there would come to a bad end. And, the historical facts seemed to bear that out. So, in 1980, Glen Phillips from the University of Chicago was brought in to conduct experiments inside the house. The notable parapsychologist said, when contacted by this newspaper, that he had recorded a series of strange phenomena in the house, from unaccountable sounds and lights to sudden temperature fluctuations. He even described episodes of missing time, which even now continue to trouble him. Mr. Phillips said he was glad to leave Brown Avenue and never return.

For the following thirteen years, the house remained unsold but continued to attract the attention of psychics, magicians, and academic researchers. While little is known of their findings (presumably as these amounted to little), one such researcher's fate was awful. Tina Yardley, a self-proclaimed psychic, spent a mere ten minutes inside the property before dropping dead of a brain aneurysm.

Following the unfortunate demise of Tina Yardley, even researchers stayed away from Brown Avenue. But, in 1993, Devon Razor brought the property back into the public's consciousness when he purchased it to hold wild parties and séances. Readers may recall the publicity surrounding the "shock rocker" and his elaborate and bloody stage shows. While Razor is said to have never made the house his home, he often spent time there with friends and groupies. Accounts of these days in Razor's autobiography, Bloody Razors, speak of weirdness in the house, but most significant is the musician's belief that he contacted the spirit of the house's designer, Remember Fletcher. Razor relates befriending Fletcher's ghost and that she would instruct him in the dark arts.

Whether Razor actually contacted the "Other Side" or if this was all just another of his well-known publicity stunts remains to be determined. Either way, he sold the house in 2004 to Brian and Heather Jensen. Unfortunately, the Jensens, like many before them, did not fare well once they moved in. In December of that year, police were called to the property when the Jensens failed to show up at work, and, on arrival, discovered a severed hand in the entrance hallway. On inspection, no further trace of the Jensons could be found, and they remain listed as missing persons. Later forensic analysis confirmed the severed hand belonged to Brian Jenson.

Now, the house on Brown Avenue is quiet. No one lives there anymore and none are likely to, given its history. So, be careful this Halloween and keep away from the house of horror!
